

ENTRIES & RACE FORMA

The number of registrations is exceptional: 490 instead of the initial maximum of 330 in Slalom, and 210 instead of the initial maximum of 150 in Kayak Cross.

Both start lists are now closed. No additional entries will be accepted for both Slalom and Kayak Cross events.

As a result, we are changing the race format, in line with the new official ICF format: the top 12 in each category will compete in the A Final; only 30% of the next best times will compete in the B Final on the basis of:

- 30 boats in WK1 (13th to 42nd),
- 30 boats in MC1 (13th to 42nd),
- 20 boats in WC1 (13th to 32nd),
- 50 boats in MK1 (13th to 62nd).

The ICF ranking remains based on the A Final and the qualifications. The PyCup ranking (Pau and La Seu) is based on the A Final, then the B Final and the qualifications.

SUBSTITUTIONS & CANCELLATIONS

Substitutions are possible but not between Slalom and Kayak Cross events. If you want to modify one of your entries, we can process it, provided that it does not add any boat to the schedule of Slalom and to the schedule of Kayak Cross. The request must be made directly to the ICF chair (<u>richard.fox@canoeicf.sport</u>) ccing the CSL technical manager (<u>thomas.rosset@canoeicf.sport</u>) precising the details of that substitution (name and event).

This process will be free of charge until the **February 25th** 11:59p.m.CET (official entry deadline) and will then be charged by the ICF.

Cancellations are possible and will be free of charge until the **February 25th** 11:59p.m. CET and will then be charged **20€ per boat** by the HOC.
